The purpose of these Public Hearings is to discuss the CDBG program in general, the needs of Mercer County, Grove City Borough and Pine Township and their performance under the previously funded CDBG program years and the required Three –Year Community Development Plans. In addition, Mercer County proposes to modify their FY 2021 and 2022 programs from removal of architectural barriers to housing rehabilitation.

Der Zweck dieser öffentlichen Anhörungen ist es, das CDBG-Programm im Allgemeinen, die Bedürfnisse von Mercer County, Grove City Borough und Pine Township und ihre Leistung im Rahmen der zuvor finanzierten CDBG-Programmjahre und der erforderlichen Drei-Jahres-Gemeinschaftsentwicklungspläne zu diskutieren. Darüber hinaus schlägt Mercer County vor,

seine Programme für die Geschäftsjahre 2021 und 2022 von der Beseitigung architektonischer Barrieren bis hin zur Wohnungssanierung zu ändern.

Mercer County is expected to receive an allocation of approximately \$722,227 of FY 2023 CDBG funds from the Commonwealth of Pennsylvania. From this \$722,227, Grove City Borough will receive \$137,661, Greenville Town \$111,700, Sharpsville Borough \$97,389 and Pine Township \$103,525. At least 70% of the available funding must be used for activities which benefit low and moderate income persons. The proposed activities must benefit at least 51% low-moderate income persons in the service area to qualify as a low-moderate income project. The PA Department of Community and Economic Development (DCED) have announced the application submission deadline of October 27, 2023.

The following types of activities may be eligible for funding under the CDBG Program: water and sewer

line replacement and improvements; housing rehabilitation; construction of affordable housing; construction/reconstruction of public/community facilities; recreational facilities; public services that are

new or provide quantifiable increases in the delivery of services; street improvements; historic preservation; removal of architectural barriers; code enforcement; economic development; acquisition and

relocation; clearance and demolition; and general administration, planning, audit if required, and preparation of the CDBG application.

If the county, borough and township would undertake activities that results in the displacement of families or individuals, then the policy for minimizing such displacement would be in effect. The county, borough and township are responsible for replacing all low and moderate income housing units that may be demolished or converted as a result of the use of CDBG funds.

All interested citizens are encouraged to attend and will be offered the opportunity to give oral testimony

at the Public Hearing and/or to present written comments concerning the needs of the Mercer County, Grove City Borough and Pine Township proposed CDBG Program activities, the prior use of CDBG funds, as well as the CDBG Program in general.
